Candidates can apply for registration for PG Admission counseling 2025 in "Online" mode only. Submission of Online Application Form may be done by accessing counseling board website **niajaipur.in** The Application Form other than online mode will not be accepted in any case.

- Only one application is to be submitted by a candidate.
- Candidates must follow the instructions strictly as given in the Information Booklet on counseling board website. Candidates not complying with the instructions shall be summarily disqualified
- Candidates must ensure that e-mail address and Mobile Number provided in the Online Application Form are their own as all information/communication will be sent by counseling board through e-mail on e-mail address or SMS on given Mobile Number only

## **Instructions for filling Online Application Form**

Follow the 4 steps given below to Apply Online:

**Step-1:** Fill in the Online Application Form and note down the system generated Application No.

**Step-2:** Upload scanned images of Candidate's Photograph, AADHAR card, Caste Certificate, Secondary Mark sheet, Senior Secondary Mark sheet, Mark sheets of B.A.M.S. (1<sup>st</sup> to Final), BAMS Degree certificate, Internship completion certificate, AIAPGET 2025 Admit Card, AIAPGET Mark sheet in JPG/JPEG format and other certificates as applicable **Step-3:** Make payment of fee using appropriate payment mode through appropriate payment gateway and keep proof of fee paid.

**Step-4:** Print at least two copies of Confirmation Page after successful remittance of fee.

## All the 4 Steps can be done together or at separate times.

#### Note:-

- The final submission of Online Application Form will remain incomplete if Step-2 and step-3 are not completed. Such forms will stand rejected and no correspondence on this account will been entertained.
- No request for refund of fee once remitted by the candidate will be entertained by counseling board under any circumstances.
- The entire application process of PG counseling is online, including uploading of scanned images, Payment of Fees and Printing of Confirmation Page. Therefore, candidates are not required to send/submit any document(s) including Confirmation Page to Counseling Board through Post/ Fax/ by Hand.
- Candidates are advised to keep visiting the Counseling Board website regularly for latest updates and also to check their-mails regularly.

#### 2. Registration

- All candidates are required to deposit registration fee of Rs. 2000/- (for Un-reserved & OBC candidates) and Rs.1000/- (for SC, ST, PwD, EWS + applicable charges through Internet banking / Debit card / Credit card). The registration fee is neither refundable, nor transferable and nor adjustable for any future State PG admissions. Any plea in this matter shall not be entertained. Please keep the information submitted in application form confidential and do not share with anybody. If you don't register during registration period, you will not be allotted any seat. Please also note that registration will be available once only.
- AIAPGET-2025 qualified candidates may apply for counseling and admission to National Institute of Ayurveda, Deemed to be University, Jaipur, if eligible based on applicable rules, regulations, reservation policy and other criteria specified by Govt. of India.

#### 3. General Instructions, Terms and Conditions

- Applicants may kindly note that appearance in PG Counseling for Academic year 2025-26 does not confer any automatic rights to secure an AYUSH Post Graduate MD (Ay) / MS (Ay) seat. The selection and admission to Post graduate seats is subject to fulfilling the admission criteria, eligibility, medical fitness and other criteria as may be prescribed by National Institute of Ayurveda, Deemed to be University, Jaipur, NCISM and Ministry of AYUSH, Government of India.
- Online Registration will begin as per schedule which will be displayed on the site.
- Applications of candidates producing false or fabricated information will not be considered and such candidates may be debarred from appearing in any future counseling conducted by counseling board.
- Incomplete application, if not in accordance with instructions, will not be considered and is liable to be rejected. Applicant should carefully fill up all the fields during registration process. Application cannot be modified/edited at any circumstances after final submission.
- The registration fee will neither be refunded nor be carried forward under any circumstances.
- Instructions in the Information-Booklet are liable to change based on decisions taken by the Institute Authorities.
- Counseling Board reserves the right to withdraw permission, if any, granted inadvertently to any candidate who is not eligible to appear in PG Counseling even though Registration number has been issued or is displayed on website
- Counseling Board does not verify the information provided by the candidates during online registration and hence candidature will be purely provisional subject to the fulfillment of eligibility criteria as mentioned in the Information Booklet for PG Counseling & criteria of National Institute of Ayurveda, Deemed to be University, Jaipur, CCIM and Ministry of AYUSH, Government of India.

#### 4. COMMON FEATURES

#### a. Qualification for Admission:

Ayurved acharya Degree (Bachelor of Ayurvedic Medicine and Surgery) recognized by CCIM/NCISM.

- **b.** (A) Only those students who have qualified in the AIPGET-2025 can participate in the counseling for admission in AYUSH PG courses for the academic year 2025-26
- (B) Minimum qualifying marks for AIPGET-2025 will be as specified in existing PG Regulations (ASU) which are given below:

"The qualifying criteria for AYUSH MD (Ay) / MS (Ay) courses shall be as per NCISM/CCIM and Ministry of AYUSH, Govt. of India directions i.e. Indian Medicine Central council (Post Graduate Ayurveda Education) Amendment Regulation 2018, In order to be eligible for admission to post-graduate courses for an academic year, it shall be necessary for a candidate to obtain minimum marks at 50<sup>th</sup> percentile for General category in the AIAPGET 2025. Qualifying criteria for candidates belonging to scheduled castes, scheduled tribes and other backward classes, the minimum marks shall be at 40<sup>th</sup> percentile. Candidate with benchmark disabilities specified under the Rights of Persons with Disabilities act, 2016 (49 of 2016) the minimum marks shall be at 45<sup>th</sup> percentile for General category and 40<sup>th</sup> percentile for scheduled caste, scheduled tribes and other backward classes."

- c. Candidates must have completed the six or twelve months rotating Internship/House Job, as the case may be, after passing the qualifying examination by **last date** (As Per Guidelines) decided by Ministry of AYUSH.( The candidates who joined BAMS courses before 2010 and graduated with 6 months internship are eligible to participate in the NIA DU-PG counseling. (Refer: CCIM Regulations 1989)
- **d.** The online application form and prospectus will be available on the Board website niajaipur.in from **19.09.2025**

#### e. Admission Procedure:

- i) Admission will be subject to the rules & regulation of the institute.
- ii) Counseling Board reserves the right to correct any inadvertent error in any merit list and also in the prospectus.
- iii) The Counseling Board shall organize counseling of the candidates and allot subjects taking into an account the Scheme of distribution of reserved seats, Merit lists of respective categories, the order of the Merit of AIAPGET 2025, Preference and Availability of seats.

- iv) The right of admission of any candidate who does not complete the prescribed internship by the date as decided by the Ministry of AYUSH, Government of India will automatically stand cancelled.
- v) Vacancies arising due to any reason will be filled by reshuffling on the Basis of Reservations and Merit-cum-Preference List from the candidates.

#### f. Selection of Candidates for Admission

Selection of the candidates for Admission will be made by a Counseling Board constituted by competent Authority. Selection of the candidates will be made strictly on the basis of AIAPGET-2025 Merit.

## g. Counseling, Merit List, Subject Preference and Allotment:

- The candidates will be allotted seats in institution through online process keeping in view Provisional Merit List, Categories, Merit in the respective Subjects, Preference, Availability of seats etc.
- After registration process candidate will have to deposit **counseling fee Rs 20000/- (Rs** Twenty Thousand only) through online payment and to submit choice filling Performa failing which their admission shall stand cancelled and they will not be eligible to participate in counseling process.
- After allocation of seats candidates must come/submit all requisite certificates, documents in original along with self attested copies of the same for verification at the time reporting to National Institute of Ayurveda, Deemed to be University, Jaipur with due fees applicable as per prevailing provisions of institute.
- In service candidates are directed to upload NOC (No Objection Certificate) along with submission of choice filling Performa and counseling fees, NOC must be issued by competent authority of respective states on or before last date of online submission. After last date of online submission NOC will not be accepted/entertained. Regular Inservice Candidates employed in Central / State Government / UT having three-year regular service (employees selected by duly constituted Selection Committee/ Board/ PSC will be considered only). Contractual service candidates will not be considered as regular service.
- Therefore, all in-service candidates must be very clear that they will get seat allocation only through online mode of In-Service quota seats, rules, category wise reservation will be strictly followed as per provisions of institute.
- vi All the In-service candidates selected for MD/MS Program through counseling 2025-26 will not get stipend from National Institute of Ayurveda, Jaipur. Their parent department/Government will provide the salary to selected In-service candidates.
